THE CASE FOR THE MIDDLE EASTERN AND NORTH AFRICAN CHECKBOX ON US FEDERAL FORMS: AN UPDATED ANALYSIS

Introduction

- The Office of Management and Budget (OMB) has proposed new data collection efforts to describe the racial/ethnic diversity of individuals living in the United States
- From January to April 2023, the OMB requested public comment on potential changes, including the addition of a separate checkbox for Middle Eastern and North African (MENA) Americans since they are defined as White
- However, research shows that MENA Americans' overall health and lived experiences often differ from White Americans from European ancestry
- The comment period yielded 20,255 public comments
- An initial review of 6,700 comments (see QR code) indicated strong support for the addition of a MENA checkbox with a wide range of countries and transnational communities in the region represented in the comments
- In this poster, we provide an updated analysis with 12,205 comments

Objective

- 1. To determine the proportion of comments that mention the inclusion of a MENA checkbox
- 2. Describe countries listed in comments supporting rationale for the need for a separate MENA checkbox

Methods

- Public comments posted on the Federal Registrar's website were compiled in Microsoft Excel
- Filtering was used to search for specific terms and comments were reviewed to determine whether they mentioned MENA or specific countries or transnational communities
- Future analysis will review will provide an update on whether the comments indicated support for a MENA checkbox and whether it was for health-related reasons.






Box 2. Current race/ethnicity categories



- in July 2023
- Most (75.11%) mentioned adding a MENA checkbox
- Top countries and transnational communities mentioned were Armenia, Assyrian, Iran, Djibouti, Lebanon, Iraq, and Syria
- This study contributes to the evidence to be used by the US Census Bureau for determining whether changes should be made to how race and ethnicity data are collected in the US going forward
